WHEREAS, the Drake Neighborhood Association and First Christian Church (herein referred to as Market Manager) are promoting a Farmers Market in the parking lot of First Christian Church, 2500 University Avenue, Des Moines, Iowa, and

WHEREAS \_\_\_\_\_, (herein referred to as a vendor) has agreed to rent a booth (also known as a stall) from said Market Manager, and

WHEREAS, the parties hereto desire to adopt an agreement assessing vendor liability against all claims, demands, actions and causes of action growing out of operations of said booth. Certificate of Liability insurance must be on record at First Christian Church; \$300,000 minimum. "Drake Neighborhood Farmers Market" must be listed as the certificate holder.

NOW, THEREFORE, in consideration of the lease of the stall herein granted and other good and valuable consideration, the vendor agrees to at all times indemnify and save harmless Drake Neighborhood Association, Drake University, and First Christian Church, and their members, successors and assigns from and against all of the following:

- 1) ALL claims, demands, actions and causes of action growing out of the operation of said booth and all costs and expenses including attorney fees in connection with any such action resulting from any loss or damage to persons or property resulting in injury or death or persons which may be due in any manor or results from the installation, operation, use, maintenance, state or repair of any stand, bay, booth, or other installation or structure of any kind.
- 2) ALL claims, demands, actions, and causes of action, together with all costs and expenses including attorney fees, as a result of or growing out of any damage, or consumption of products or goods from any booth, or other installation of any kind.

Vendor shall pay to First Christian Church (c/o Drake Neighborhood Farmers Market) the full amount of any loss or damage which it may sustain, incur or become liable for on account thereof, including, but not limited to, court costs and attorney fees.

Vendor has received and read and understands and agrees to follow all rules and regulations set forth by the Drake Neighborhood Farmers Market as stated in the 2011 Rules and Regulations.

Vendor gives approval for the Drake Neighborhood Farmers Market, and its sponsors, to use photographs taken at the Market that might include my work for publicity purposes.
